Aims and Scope

RHEUMATOLOGY INTERNATIONAL will cover all modern trends in clinical and experimental research as well as in the management of rheumatic diseases. Special emphasis will be given to immuno-pathogenetic mechanisms, inflammatory reactions, collagen metabolism, genetics, epidemiology, therapeutic modulation of immunological and inflammatory mechanisms, and development and evaluation of diagnostic procedures connected with rheumatic diseases. Contributions to these topics will appear in the form of original publications, informative case reports, short communications, editorials, and reviews. "Letters to the editor" will be welcome as an enhancement to discussion. Every effort will be made to ensure speed of publication while maintaining a high standard of contents and production.

Manuscript submitted for publication must contain a statement to the effect that all human studies have been reviewed by the appropriate ethics committee and have therefore been performed in accordance with the ethical standards laid down in an appropriate version of the 1964 Declaration of Helsinki. It should also be stated clearly in the text that all persons gave their informed consent prior to their inclusion in the study. Details that might disclose the identity of the subjects under study should be omitted.

Reports of animal experiments must state that the "Principles of laboratory animal care" (NIH publication No. 86-23, revised 1985) were followed, as well as specific national laws (e.g. the current version of the German Law on the Protection of Animals) where applicable.

The editors reserve the right to reject manuscripts that do not comply with the above-mentioned requirements. The author will be held responsible for false statements or for failure to fulfil the above-mentioned requirements.

Instructions to authors

The author(s) transfer(s) the copyright to his/their article to Springer-Verlag effective if and when the article is accepted for publication. The copyright covers the exclusive and unlimited rights to reproduce and distribute the article in any form of reproduction (printing, electronic media or any other form); it also covers translation rights for all languages and countries. For U.S. authors the copyright is transferred to the extent transferable.

Manuscripts must be in English, typed double-spaced on one side of the paper only and with at least 5 cm (2 inches) margins. To facilitate the review process, the original manuscript (typed on one side of the paper only) should be accompanied by two duplicate copies (photocopied on both sides), and photographic material should also be submitted in triplicate. Three manuscript pages are roughly equal to one printed page (approximately 900 words).

All manuscripts are subject to **copy editing** and will, if necessary, be returned to the authors for open questions to be resolved before the manuscripts are sent to the printers for composition. In addition, the editors reserve the right to condense manuscripts. If corrections are extensive, the author is responsible for having the manuscript retyped. In order to reduce the printing process it is mandatory to send the final accepted version of the manuscript on disc to Springer-Verlag. In order to reduce mailing costs, rejected manuscripts will not normally be returned.

Manuscripts in electronic form. All manuscripts, both original submissions and revisions, must be accompanied by a diskette corresponding exactly to the hard copy. The author is requested to follow the publisher's instructions for the preparation of electronic manuscripts and digital images.

Papers are to be presented in the following order:

Page 1: (1) name(s) of the author(s); (2) title of the paper; (3) name and address of each author [specify corresponding author with an envelope (✉) and furnish telefax number or e-mail address].

Page 2: Abstract (only for original papers) of no more than 150 words; about 5 key words.

Rest of paper: Text; acknowledgements; references; tables (arabic numerals) with table titles; concise figure legends (arabic numerals).

Form and contents should be carefully checked to exclude the need for later corrections as corrections exceeding 10% of the cost of typesetting will be charged to the author. To allow fast publication, only one set of proofs will be sent to the authors. These proofs will show figures and tables in their final position. Therefore, the manuscript must be in its final form and properly prepared for the printer. In the manuscript the approximate positions of figures and tables must be marked in the margin.

Only typographical errors should be corrected. Essential additions may be placed at the end of the page proofs as a "Note added in proof."

Please use ample subheadings and arrange your text as follows:

Abstract. State the main points. This should be comprehensible without reference to the text.

Introduction. State briefly the nature and purpose of the work, quoting the relevant literature. Do not state results.

Materials and methods. Include details of clinical and technical procedures. An indication must be made that informed consent has been obtained from patients where appropriate, and if performed in humans the reported investigations must have been performed in accordance with the principles of the Declaration of Helsinki.

Results. Present these clearly, concisely and without comment.

Discussion. Explain your results and relate them to those of other authors; define their significance for clinical practice.

References. Only essential references should be listed, and these should also be cited in the text. Be sparing with citations of historical importance. Arrange them in the order in which they are quoted in the text. Number them and cite by number only in the text. Give preference to those which cite additional literature. Journal references should give names and initials of all authors, year, full title, journal as abbreviated in **Index Medicus**, volume number and first and last page numbers. Example:

1. Lange U, Teichmann, J, Stracke, H, Bretzel RG, Neeck G (1998) Elderly onset rheumatoid arthritis and polymyalgia rheumatica: ultrasonographic study of the glenohumeral joints. *Rheumatol Int* 17: 229–232

Books are cited similarly, with edition, publisher and place of publication. Example:

2. Sattler H, Harland U (1988) *Arthrosonographie*. Springer, Heidelberg, New York

The references are the responsibility of the authors. They must be prepared correctly and then rechecked by the authors in the page proofs.

Footnotes should not be used.

Illustrations. Keep them separate from the text. The best possible reproduction of prints results when the print submitted is of a size identical with that desired in the published paper. Line drawings, radiographs and photographs (clear, sharp, well-contrasted) should be submitted as good-quality prints, trimmed at right angles and in their final printed size (up to 8.6 cm for column width, up to 17.6 cm for page width). Computer drawings are acceptable provided they are of comparable quality to line drawings. Lines and curves must be smooth. All illustrations must be numbered and the top indicated on the back.

Insets, lettering, arrows, etc, should be applied using template rub-on letters or carefully inserted by an experienced hand. The lettering should be about 2 mm high. The author must guarantee that the reproduction of illustrations in which a patient is recognizable is either approved by the patient him/herself or his/her legal representative. Color illustrations will be accepted; however, the authors will be expected to make a contribution towards the extra costs (EUR 485.73 per article).

Tables should have a title and a legend explaining any abbreviation used in that table. Notes to tables should be indicated by superscript letters.

Passages to be set in small print should be marked with a vertical line and a "p" in the margin. **Single words to be emphasized by italics** should be underlined.

Offprints. Offprints may be ordered at cost when the page proofs are returned. Springer will supply the corresponding author with two free copies of the relevant issue.
